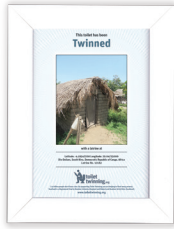

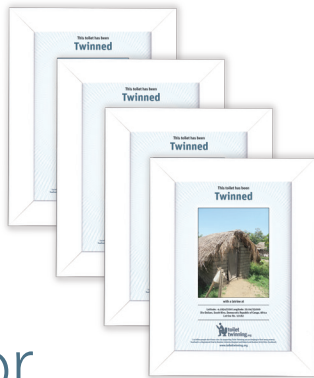

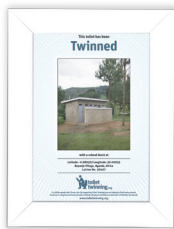

Can I donate regularly to Toilet Twinning?

Every donation to Toilet Twinning is welcomed with open arms. Family by family, community by community, nation by nation – we are changing the world one toilet at a time.

You can twin your toilet with a latrine in a poor community by giving a one-off donation of £60 – or you might prefer to spread your donation over the whole year. You could:

- donate **£5 per month**, and receive your Toilet Twin at the end of a year
- donate **£10 per month** for a twin every six months
- donate **£20 per month** and receive four twins per year or a school block twin at the end of the year

How should I give?

Giving by Standing Order is the way to give regularly to Toilet Twinning. We've suggested monthly amounts, but you can also give quarterly or annually.

When you set up a Standing Order with your bank, please contact us, so we know to look out for your donation.

If your circumstances change, you can increase, reduce or stop your giving at a moment's notice by contacting your bank.

Will I receive a twin when my standing order reaches £60?

We won't be notified automatically when your giving reaches £60 – so you'll need to ask us for a Toilet Twinning certificate. Please tell us if you wish to twin with a particular country, and let us know of any personalisation for your certificate. We'll also need your address.

GIFT AID DECLARATION – MULTIPLE DONATION

Boost your donation by 25p of Gift Aid for every £1 you donate. Gift Aid is reclaimed by the charity from the tax you pay for the current tax year. Your address is needed to identify you as a current UK taxpayer.
